Call to Order

Presentations

A. Flock Camera pilot program update to the City Council

FLOCK Camera Presentation for Council.pptx

Asst. Chief Lawless made a presentation regarding FLOCK cameras - automated license plate readers. He discussed the technology, how privacy is protected, examples of footage, types of data collected, and optional software integrations. Currently there are five cameras in Marysville. He reviewed statistics of the license plate reads to date, discussed benefits of information sharing with other agencies, and highlighted recent successes. Police think it would be beneficial to add more cameras and have identified five specific locations for them.

Councilmembers asked questions about who inputs the criteria for what to look for, camera installations/locations, life expectancy, and what kinds of vehicles this works for. Councilmembers expressed appreciation for the presentation and requested more updates in the future. There was a question about if these were live feed cameras. Asst. Chief Lawless explained that it only takes encrypted still frame photos, but there can be an interface with the software for additional information. A concern was raised about privacy. Asst. Chief Lawless reiterated there is no facial recognition and it only reads the license plate. He noted that there are safeguards in place with making queries, data is not stored long-term, and ACLU supports the use of these cameras.
